Clerk Report:

- Town Clerk thanked retiring Trustees for their efforts and commitment to improve the Town.
- Highland Dictionary Fund is requesting donation. In the past the Town has donated \$50 each year.
- Volume of Court is no longer manageable for the existing staff. Linda will need to concentrate her efforts
 in the Maintenance Department over the summer due to increased workload in that department during
 the summer months. The last court docket had 70 arraignments which is way beyond the initial average
 docket of 20 arraignments. Would like approval to hire a temporary court assistant for up to six months.
- Don Sandoval from DOLA stopped by to let us know he is available to talk with the Town Board about funding and projects we may need assistance on.
 - Mr Sandoval stated he continually receives emails from one of our residents and responds out of courtesy. He is not available to be a Town Manager and said the Town does not need one at this time. He did provide a couple of names for Town planners that could be utilized on an as needed basis to assist with our planning department.
- There will be a meeting a 1:30 p.m. tomorrow in the Board Room with Weld County to discuss CR 98 expansion.
- Newly elected officers will need to come into Town office next week to pick up their packet of materials and laptop check out.
- First quarter budget performance copies are available for review.

- Variance Request for 1424 2nd St: Resident requesting a variance to keep 2 horses on their 2.2 acres at this address. Resident provided letter dated September 13, 1994 indicating the current owner would be allowed to continue the grazing use. Board agreed this property was not zoned Ag, which would be required to continue the use, but zoned Residential and the property has changed ownership and the use had been abandoned.
